## Call for consultation

**The Electoral Institute of the State of Guanajuato**, based on the provisions of articles 1, 35 sections I and II, 41 section V and C, and 133 of the Political Constitution of the United Mexican States; 1, 2, 7 and 21 of the Universal Declaration of Human Rights; 25 of the International Covenant on Civil and Political Rights; 23 of the American Convention on Human Rights; 41 and 42 of the International Convention on the Protection of the Rights of All Immigration Workers and Their Family Members; Principle 31 of the Inter-American Principles on the Human Rights of All Migrants, Refugees, Stateless Persons and Victims of Human Trafficking; Articles 1, 15, 31, 42 and 45 of the Political Constitution for the Free and Sovereign State of Guanajuato and; 2, 3, 10 and 11 of the Law to Prevent, Address and Eradicate Discrimination in the State of Guanajuato.

# Calls:

All Guanajuato citizens who are migrants and residents abroad, as well as leaders from Guanajuato Migrant Organizations, who are interested in participating in the free, informed, and in good faith pre-consultation.

The purpose is to receive your opinions, proposals, and points of view regarding the implementation of the **affirmative actions** and the appropriate regulatory mechanisms for the accreditation of the **qualified self-adscription** in the application of nominations for the **Local Election Process 2026-2027**, in order to substantively guarantee your political-electoral and political representation rights.

The consultation will be carried out as follows:

## Bases

### First. Actors of the Consultation Process.

- a) Persons to consult:** Guanajuato Citizens who are migrants residing abroad, as well as leaders from Guanajuato Migrant Organizations.
- b) Responsible Authority:** The Electoral Institute of the State of Guanajuato (IEEG).
- c) Technical Bodies:** The Secretariat of Human Rights of the State of Guanajuato, through the Undersecretary of Immigrant Care and Mobility Frameworks.
- d) Guarantor body:** The Ombudsperson's Office for Human Rights of the State of Guanajuato (PRODHEG).

### Second. Object and Subject of the Consultation.

The purpose of the Consultation will be to collect opinions, comments, proposals, and suggestions on the affirmative actions implemented by the IEEG in the Local Election Process 2023-2024, particularly regarding the application of migrant deputies and districts, as well as on the appropriate and sufficient mechanisms to accredit qualified self-adscription.

### Third. Participation Modalities.

In view of the use of Information and Communication Technologies (ICT) and to maximize participation, the phases of the consultation will be conducted in a **virtual format**. The consultation questionnaires will be available in digital format on the official IEEG microsite and on the social platforms of "Voto Guanajuatense en el Extranjero."

Also, the IEEG will guarantee the interpretation of the necessary information in Mexican Sign Language across the different phases of the Consultation, as well as the translation of the information into English, with the intention of promoting greater dissemination and in accordance with the right to information.

### Fourth. Procedure and Phases of the Consultation.

**a) Information and deliberative phase:** The IEEG will disseminate the call, and informational materials through the official IEEG microsite and on the social networks of "Voto Guanajuatense en el Extranjero", migrant organizations, and Mexican consulates abroad.

**b) Consultative Phase:** In this phase, two avenues are considered to carry out the Consultation:

**1. Two virtual dialog tables** via Zoom platform on **July 10th** from 7 p.m. to 9 p.m. Central time (6 p.m. to 8 p.m. California time and 8 p.m. to 10 p.m. Texas and Illinois time).

As well as **July 11th** from 5:00 p.m. to 7:00 p.m. Central time (4:00 p.m. to 6:00 p.m. California time and 6:00 p.m. to 8:00 p.m. Texas and Illinois time).

The dialogue tables will be recorded, so the authorization of each participating person will be requested in advance to record their voice and image, in order to formally collect the proposals, opinions, and points of view that meet the objective of the Consultation. In addition, Minutes of each dialogue table will be issued.

**2. Online Questionnaire** through the official IEEG microsite and the social platforms of "Voto Guanajuatense en el Extranjero" from **July 10** to **August 10**.

**c) Monitoring Phase of Agreements and Systematization:** During August 2026, the IEEG will systematize the information collected through the questionnaires and dialogue tables. A technical report and the draft agreement will be prepared to integrate the viable opinions for the final issuance of the affirmative actions of the Local Election Process 2026-2027 by the General Council, prior to the formal start of the electoral process.
